Weddings at Eagle Bluff Lighthouse



In 1900, Charles Duclon and his future wife, Edith, were wed in the yard of Eagle Bluff Lighthouse. They were surrounded by William Duclon, the lighthouse's keeper, and their family and friends. Today, Eagle Bluff Lighthouse invites brides and grooms to exchange their vows in the tradition of Charles and Edith.

Guidelines for planning a wedding on the grounds of this historic 1868 lighthouse:

- Wedding ceremonies can be held during the regular lighthouse season, mid-May through mid-October.
- Weddings may be held beginning at 4:30 or 5:00 pm any day of the week.
- Brides may utilize the lighthouse prior to the ceremony.
- We recommend you select an alternate site in case of inclement weather.
- The interior of the lighthouse is available for very small intimate weddings due to space (20 people or less).
- ◆ The lighthouse is available for a walk-through tour following the exchange of vows.
- A Peninsula State Park daily admission sticker is required for every vehicle that enters the park. It is your responsibility to advise your guests that a permit is required.
- Parking is limited; carpooling is highly recommended.
- The use of chairs on the grounds is permissible; you are responsible for arrangements and setup.
- The use of alcohol and tobacco is prohibited.
- Lighthouse staff will be on-site during and following the ceremony to supervise the grounds and building.
- Any hired contractors such as photographers or clergy must secure a permit from Wisconsin DNR.

Wedding Rates: \$300 first 1-1/2 hour; \$100 each additional hour

The Chapel graciously accommodates 35-45 guests, providing an atmosphere where time seems to stand still.

While open to the public from June through mid-October, we understand the significance of exclusive moments. When you reserve the Chapel for your special occasion, we will close the building to the public, ensuring that your day is as unique as the love and memories you celebrate within its walls.
